Our Treatment Approach:

GSBC clinical counsellors will be required to use Feedback Informed Treatment (FIT)* to deliver counselling services related to gambling addiction to B.C. residents. Counsellors will also be required to market and promote such counselling services to reduce gambling harms and increase awareness of such available services to B.C. residents. *You do not need experience with FIT to apply – for the right candidate, we can provide this training.

Requirements:

- The Respondent must demonstrate at least 2,700 hours (3 years full-time) of experience delivering supervised clinical counselling services related to addiction and mental health issues. This must be clearly demonstrated in the resume.
- Must have experience in bio-psycho-social-spiritual assessment as required for addictions and mental health treatment, group and individual counselling as well as facilitating psychoeducation.
- Preference may be given to those with gambling or process addiction counselling experience.
- The Respondent must have a **master's degree in counselling** from an accredited university or be a **Registered Psychologist** or **Registered clinical social worker**. Supporting documents including relevant transcripts, proof of completion, or current enrolment and anticipated completion must be included with the Respondent Qualification form.
- The Respondent must be registered with **one** of the following professional associations: Canadian Counselling and Psychotherapy Association, BC Association of Clinical Counsellors, BC Psychological Association, or must hold designation of Registered Clinical Social Worker if registered with the BC College of Social Workers. Proof of registration/membership must be included with the Respondent Qualification form.
